



#### **HMA Trends at IDOT**


- 2017: 4.7M tons
- 2018: 3.2M tons
- 2019: 4.7M tons
- 2020: 6.6M tons
- 2021: 5.1M tons
- 2022: 4.7M tons as of Feb
  - Estimated 5.1M after additional data
- 2023 projected: 3.8M tons
  - Nov-June lettings, no carry-over

## **Construction & Materials Management System (CMMS)**

- Improved collaboration between Construction and Materials
- QMP Package web-based solution, interface with CMMS
  - Mix designs and test data
- QMP Package tools stand-alone, random numbers and pay factor calculations

- Does not include Remove & Replace (~2% of OAL)





- Collaboration is critical




# **FLS Waterproofing System for Bridge Decks**

- FLS and low permeability HMA (easier to achieve higher density with static rolling)
- Prevents ingress of water and chlorides
- Improved wearing surface
- More efficient & cost-effective means of construction than System in 581







# **FLS Waterproofing System for Bridge Decks**

- Good performance after 3 years
- No longer experimental
- Working on BDE Special Provision
