

Adjusted Annual Highway Improvement Program

While the ILDOT's FY2022 For the Record, which summarizes the program accomplishments, has not been released, the Department provides quarterly updates on its website.

According to the adjusted annual highway improvement program dashboard, FY22 Q4 programmed costs were \$5.3 billion (3,063 projects) with awarded costs of \$3.3 billion (2,162 projects). The original annual highway improvement program was \$3.6 billion.



For project count, this represents a 71% accomplishment rate for the FY22 Q4 adjusted program compared to an FY20 Q4 rate of 91% and an FY21 Q4 rate of 69%.

For program cost, this represents a 62% accomplishment rate for the FY22 Q4 adjusted program compared to an FY20 Q4 rate of 78% and an FY21 Q4 rate of 53%.



Us Department of Labor announces changes to OSHA's Severe Violator Enforcement Program to strengthen enforcement, improve compliance

WASHINGTON – To strengthen enforcement and improve compliance with workplace safety standards and reduce worker injuries and illnesses, the U.S. Department of Labor is expanding the criteria for placement in the Occupational Safety and Health Administration's <u>Severe Violator Enforcement Program</u>.

The <u>new criteria</u> include violations of all hazards and OSHA standards and will continue to focus on repeat offenders in all industries. Previously, an employer could be in the program for failing to meet a limited number of standards. The changes will broaden the program's scope with the possibility that additional industries will fall within its parameters.

Since 2010, the Severe Violator Enforcement Program has focused on enforcement and inspection resources on employers who either willfully or repeatedly violate federal health and safety laws or demonstrate a refusal to correct previous violations. In addition to being included on a public list of the nation's severe violators, employers are subject to follow-up inspections.

Capitol Update



2022 General Election

Early voting started on Thursday, September 29, 2022, and will conclude on Monday, November 7, 2022. Mail-in ballots must be returned by or postmarked on Tuesday, November 8, 2022.

In addition to the elected offices, the Workers' Right Amendment would add the following section to the Illinois Constitution:

"Section 25. Workers' Right. (a) Employees shall have the fundamental right to organize and to bargain collectively through representatives of their own choosing for the purpose of negotiating wages, hours, and working conditions, and to protect their economic welfare and safety at work. No law shall be passed that interferes with, negates, or diminishes the right of employees to organize and bargain collectively over their wages, hours, and other terms and conditions of employment and workplace safety, including any law or ordinance that prohibits the execution or application of agreements between employers and labor organizations that represent employees requiring membership in an organization as a condition of employment. (b) The provisions of this Section are controlling over those of Section 6 of Article VII."

Proponents argue that the amendment is needed to protect workers' right to unionize and bargain. while opponents argue that this amendment would give unions unprecedented control, increase property taxes, and put Illinois at a competitive disadvantage with surrounding states.
